

Salient Features of Memorandum of Understanding (MOU) between YPF and Sustainable Social Development Organization(SSDO):

The collaboration between the three parties has the main purpose of conducting Advocacy & Research on the issues of peace and Sustainable Development in Pakistan.

SSDO will bear the cost for organizing the advocacy seminars.

Young Parliamentarians Forum(YPF) will provide overall support and guidance for the successful implementation of the advocacy seminars. Whereas the PIPS will mobilize legislators and help in undertaking the administrative arrangements.

The collaboration between the parties will aim for the following outcomes:

- i. Orient and sensitize young Parliamentarians on issues of peace and sustainable development in Pakistan, its opportunities and challenges in Pakistan.
- ii. Build a pool of young parliamentarians to champion for youth's social awareness on the issues of peace and sustainable development.

Salient Features of Memorandum of Understanding (MOU) between YPF and Study International SI-UK(Pakistan):

The collaboration between the YPF and SI-UK(Pak) aims to conduct advocacy seminars on different national and international goals in different fields to promote national interest.

- i. SI-UK(Pak) will facilitate YPF to manage social media activities.
- ii. SI-UK(Pak) will depute a human resource with YPF Secretariat for assistance in managing website, social media accounts, and other activities of YPF.
- iii. Being affiliated to the top universities of UK, SI-UK(Pak) will facilitate members of YPF for exchange programmes, access to the short courses of top universities and for foreign degrees on honorary basis.
- iv. YPF will be responsible to provide overall guidance and platform to hold the seminars whereas PIPS in the role of YPF Secretariat will be responsible to facilitate mobilization and other administrative tasks for organizing the seminars.
- v. Being connected to the universities all across Pakistan, SI-UK(Pak) will assist YPF in its Parliamentary Youth Ambassador Programme(PYAP) by engaging the youth of the universities across Pakistan.

Salient Features of Memorandum of Understanding (MOU) between YPF and Shaor Foundation for Education & Awareness(SFEA):

The collaboration between the YPF and Shaor Foundation for Education and awareness (SFEA) aims to conduct advocacy seminars with Parliamentarians on human rights issues under “**HumAhang for Rights Project**” as per shared work plan. In addition, the collaboration between the YPF and SI-UK(Pak) aims to conduct advocacy seminars on different national and international goals in different fields to promote national interest.

Following are the specific activities that will be carried out under this partnership

- i. 04 sensitization and consultative sessions with Parliamentarians in Khyber Pakhtunkhwa, Punjab, Sindh and Balochistan Assembly.
- ii. 02 post legislative scrutiny workshops with Parliamentarians.
- iii. 02 dialogue with university students each in Punjab and ICT on topic “Youth in Parliament” development advocacy videos.
 - a. 02 videos with Parliamentarians on role of HumAhang Project.
 - b. 01 video with YPF office bearer on YPF and project Partnership.

- iv. 04 radio programmes with the participation of YPF/Parliamentarians in a panel discussion on human right issue with other relevant thematic experts.
- v. Development of YPF website.

YPF will be responsible to provide overall guidance platform to hold the aforementioned events whereas PIPS (in the role of YPF Secretariat) will be responsible to facilitate mobilization and other administrative tasks for organizing these events.

Salient Features of Memorandum of Understanding (MOU) of YPF with National Commission on the Rights of Children (NCRC):

The collaboration between the parties has the following purpose:

Conduct advocacy seminars on “**Legal Framework for Child Rights and Child Protection in Pakistan.**” The seminars will aim to highlight the need to deal with the rights and protection issues affecting children in Pakistan and available legal and institutional framework to protect children in Pakistan.

The collaboration between the parties will aim for the following outcomes:

- i. An understanding on key child rights and child protection issues in Pakistan.
- ii. An understanding on international treaties on children ratified by the Government of Pakistan and Pakistan’s Obligations.
- iii. An understanding of national and provincial legal frameworks and institutional framework to protect children in Pakistan.
- iv. Identifying roles of Parliamentarians and other stakeholders to protect rights of children in Pakistan.

YPF will be responsible to introduce NCRC to YPF Members and facilitate meaningful participation. YPF will be responsible to provide overall support and guidance for the successful implementation of the advocacy seminars in close collaboration with NCRC.

Salient Features of Memorandum of Understanding (MOU) between YPF and Youth Parliament of Pakistan:

The collaboration between the parties aims to conduct advocacy seminars on different national and international issues to engage youth for nation building specifically as:

- i. United Nations Sustainable Development Goals including seminars or dialogue session on Climate Change, Good Health, Quality Education, Peace, Justice, and strong Institutions.
- ii. Pakistan National Days including Pakistan Day Youth Convention or Summit, Kashmir Day as International Kashmir Parliamentary Conference by engaging National and International Parliament members.
- iii. International Days and Linkages including Human Rights Day- Violation of Human Rights in IIOJK and International Youth Day with the engagement of International Youth Activists and Organizations.
- iv. Sidewise events including Youth Parliament Delegation visit to Parliament House and International session with YPF Members.
- v. Additional Initiatives may be taken to bridge the gap between youth and Parliamentarians such as youth engagement in Legislative reform draft and training programmes.

Salient Features of Memorandum of Understanding (MOU) of YPF and Signify Consulting Pvt Limited:

The collaboration between YPF and Signify Consulting Pvt Limited aims to build capacities of Young Parliamentarians and establish a multi-stakeholder working group with membership from educational institutions' leadership, and other relevant stakeholders.

The collaboration between the parties aims for the following outcomes:

- i. Build capacities of Young Parliamentarians in technical and social areas which may include strategic leadership, effective communication, legal writing and other topics as identified during needs assessment.
- ii. Orient and sensitize young Parliamentarians on SDGs especially on
 - SDG 4:** Quality Education for all
 - SDG 5:** Gender Equality
 - SDG 8:** Decent work and Economic growth
 - SDG 10:** Reduce Inequalities
 - SDG 13:** Climate action
 - SDG 16, 17:** its challenges and opportunities in Pakistan.
- iii. Build a pool of young Parliamentarians to champion for youth's social awareness of the cross-cutting impact of social cohesion, diversity and inclusion especially for achieving sustainable development.

Salient Features of Memorandum of Understanding (MOU) between YPF and Population Centre Pakistan(PCP):

The collaboration between the parties aim to conduct advocacy seminars on “**Meeting Pakistan’s Population Challenges.**” The advocacy sessions will engage members of YPF from the National Assembly and seek to include young parliamentarians from the four provincial assemblies and two legislative bodies of Gilgit-Baltistan and Azad Jammu & Kashmir.

The collaboration between the parties has the following purpose:

- i. Conduct advocacy seminars on “Meeting Pakistan’s Population Challenges.”
- ii. Orient and sensitize young parliamentarians on population dynamics, its opportunities and challenges for Pakistan.
- iii. Build a pool of young parliamentarians to champion for youth social awareness of the cross cutting impact of rapid population growth on day to day living and the need for balanced and sustainable population growth in the country.
- iv. YPF will be responsible to introduce PCP to the YPF members and facilitate meaningful participation.
- v. YPF will provide overall guidance and platform to hold the seminars whereas PIPS (in the form of YPF Secretariat) will be responsible to facilitate mobilization and other administrative tasks for organizing the seminars.
